Introduction / Overview

The WTS-AM provides a convenient way to provide power and connect to a load cell or high level output transducer.

The module provides a power via a pair of 'AA' cells, there is an LED transmission indicator which will also serve as a visual indication that there is sufficient battery power for operation.


Connecting an input to the acquisition module is also made easier by utilizing screw terminals. The case is environmentally sealed to IP65.

Getting Started

There are several versions of the WTS-AM depending on which type of input is required, therefore the type must be specified at the time of ordering.


Opening the Case

The case lid is secured with 4 x M3 Hexagon button head screws, remove the four screws and apply pressure in either off set corner as shown below.



Connecting Power

Power can be supplied by installing 2 X 'AA' cell 1.5 Volt batteries.




LED Indicator

The WTS-AM has an LED to provide a visual indication of data transmission from the acquisition module inside. The LED flashes when ever a data transmission occurs.

Antenna Orientation

The WTS-AM has a printed circuit board (PCB) antenna, when the lid is in place the antenna sits under the case lid toward the cable entry side of the module, this is a useful reference when orientating the module for optimum reception.

Connecting Input Signals



The input connections are accessed by lifting the right hand cover plate, this plate incorporates the PCB Antenna; take extra care when re-assembling that the grey UHF cable remains attached to the antenna socket.

The connection of the input signals is dependent on what type of acquisition module is installed. Please refer to the table below.



Mounting Options



The WTS-AM has two mounting holes as shown above; these mounting holes are external to the seal but still covered by the case lid to offer some environmental protection for the mounting screws. In addition mounting can be made through the back of the case however a seal or gasket must be used to maintain environmental protection.

OEM / Reseller Marking and Documentation Requirements

FCC

The Original Equipment Manufacturer (OEM) must ensure that FCC labelling requirements are met. This includes a clearly visible label on the outside of the final product enclosure that displays the contents as shown:

Contains FCC ID:VHARAD24

This device complies with Part 15 of the FCC Rules. Operation is subject to the following two conditions:

- (1) this device may not cause harmful interference and
- (2) this device must accept any interference received, including interference that may cause undesired operation.

The acquisition modules have been tested with only certain antenna types. When integrated in OEM products, fixed antennas require installation preventing end-users from replacing them with non-approved antennas. Antennas other than previously tested types must be tested to comply with FCC Section 15.203 (unique antenna connectors) and Section 15.247 (emissions).

Acquisition modules have been certified by the FCC for use with other products without any further certification (as per FCC section 2.1091). Changes or modifications not expressly approved by Interface could void the user's authority to operate the equipment.

In order to fulfil the certification requirements, the OEM must comply with FCC regulations:

- 1. The system integrator must ensure that the text on the external label provided with this device is placed on the outside of the final product.
- 2. The acquisition modules with external antennas may be used only with Approved Antennas that have been tested by Interface.

IC

Labelling requirements for Industry Canada are similar to those of the FCC. A clearly visible label on the outside of the final product enclosure must display the following text:

Contains Model RAD24 Radio (2.4 GHz), IC:7224A-RAD24

Integrator is responsible for its product to comply with RSS-210 - Low-power Licence-exempt Radio communication Devices (All Frequency Bands): Category I Equipment RSS.

CE

The WTS series has been certified for several European countries.

If the acquisition module is incorporated into a product, the manufacturer must ensure compliance of the final product to the European harmonized EMC and low-voltage/safety standards. A Declaration of Conformity must be issued for each of these standards and kept on file as described in Annex II of the R&TTE Directive. Furthermore, the manufacturer must maintain a copy of the WTS device user manual documentation and ensure the final product does not exceed the specified power ratings, antenna specifications, and/or installation requirements as specified in the user manual. If any of these specifications are exceeded in the final product, a submission must be made to a notified body for compliance testing to all required standards.

OEM Labelling Requirements

The 'CE' marking must be affixed to a visible location on the OEM product.



The CE mark shall consist of the initials "CE" taking the following form:

- If the CE marking is reduced or enlarged, the proportions given in the above graduated drawing must be respected.
- The CE marking must have a height of at least 5mm except where this is not possible on account of the nature of the apparatus.
- The CE marking must be affixed visibly, legibly, and indelibly.
